The following details relate to an educational excursion to **The National Zoo & Aquarium** which is being organised for **Kindergarten**.

Purpose of excursion: to extend the learning undertaken in the inquiry unit 'Staying Alive' about our knowledge of habitats by observing animals living in various spaces with different features.

Activities: Class groups will be walking around the zoo with their teacher and parent helpers, observing different animals. Class groups will stop for morning tea whilst walking around the zoo and stop for lunch with the other classes at the playground.
