PARENT/ CARER PERMISSION FOR THIRD PARTY SOFTWARE USE

Amaroo School is committed to providing educational experiences for all children which support the use and development of digital technologies. To support these experiences educators, draw upon a range of third-party software to:

- Enrich learning experiences.
- Develop strong links and partnerships between home and school.
- Develop student capacity to engage and create with digital technologies.

What is Seesaw?

Seesaw is a secure online learning tool available for educators and students to upload and share student learning. This may include photos/videos of completed work, active learning, cooperative play, excursions and school events. Families can comment on and respond to their child's learning through the information that is shared privately with you and other family members. We value collaboration in our classrooms, this means our students participate in group tasks/ projects and at times your child's first name and photo/video may be included in other children's portfolios (if permission has been given).

For your child to use Seesaw, certain information needs to be provided about the child to be able to associate their photos, videos and learning with their account (see full details listed in the table below). Seesaw only uses this information to provide the service and does not advertise in Seesaw, create profiles of students, or share or sell your child's personal information or journal content. Further information surrounding the use of this platform may be obtained by visiting the Seesaw website. In addition, we encourage you to read and understand the Seesaw Privacy Policy.

How will Amaroo School use Seesaw?

Amaroo School will use the platform to:

- upload and share student learning.
- provide families an opportunity to engage and comment on their child's learning and their progress towards learning goals.
- provide reminders on routines and upcoming events.

The school will not use Seesaw as a way of communicating with parents on aspects such as learning or behavioural concerns, student wellbeing and/or messages such as changes to pick up arrangements. This will need to be done via email with the class teacher.
