# **Meeting Minutes**

# 1. Procedural/Administrative

2. Welcome (President)

President opened the meeting at 7:05pm and thanked everyone for attending. An acknowledgement of country was also made.

# 3. Confirmation of 2023 AGM minutes

Secretary moved that the minutes of the 20 March 2023 Annual General Meeting be approved as an accurate record of that meeting. Seconded by Treasurer. CARRIED

# 4. Presidents Report

The President provided a summary of the key activities over 2023 including:

- Disco
- Canteen and Uniform Shop additional roles
- Now have 7 Canteen staff and 1 Uniform Shop as P&C staff
- Audit report was mentioned to be detailed in General meeting.

# 5. Financial Report

Treasurer presented the 2023 audited financial statements and auditors report. Secretary moved that the financial statements been accepted, and Tegan and Emma seconded. CARRIED

The Treasurer noted that the auditor's letter to the P&C Committee outlined some suggestions for continuing to improve the financial management of the P&C. These suggestions will be addressed at the general meeting.

The net profit for the P&C for 2023 was \$3,140.22, compared with a deficit of -\$1,174.72 in 2022. P&C donated \$7,580 to the school for a range of items including pre-school playground equipment, paper recycling bins etc.

The P&C's cash at bank as at 31 December 2023 was \$51,583.39. The P&C holds 4 bank accounts (after consolidating the pre-school Account last year) with the following balances as at 31 December 2023.
